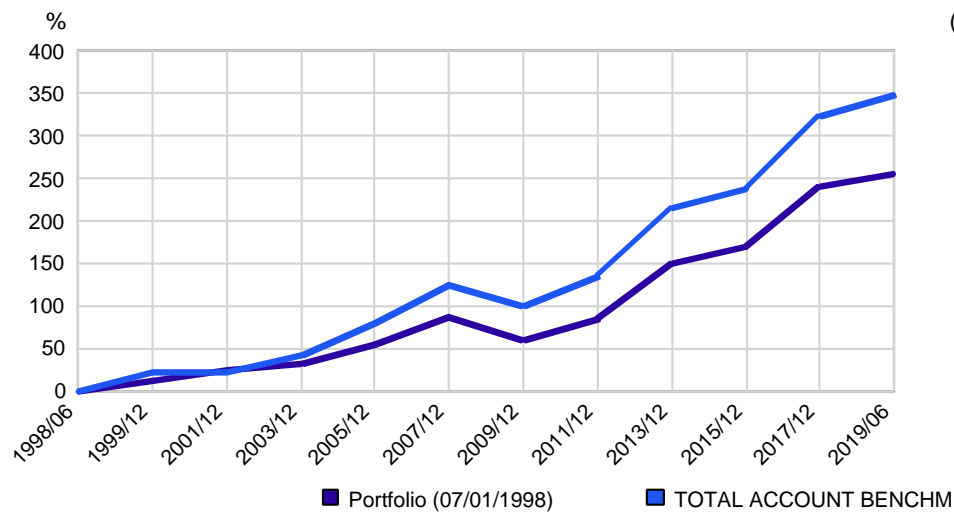

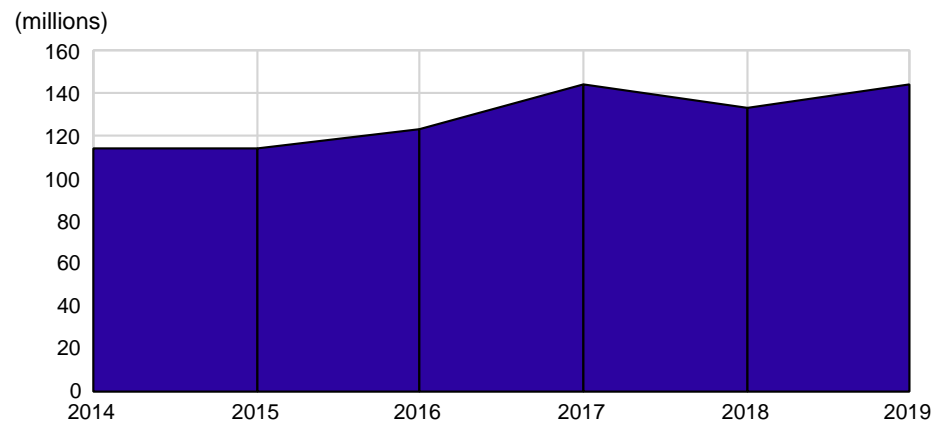

Value Added Over Time

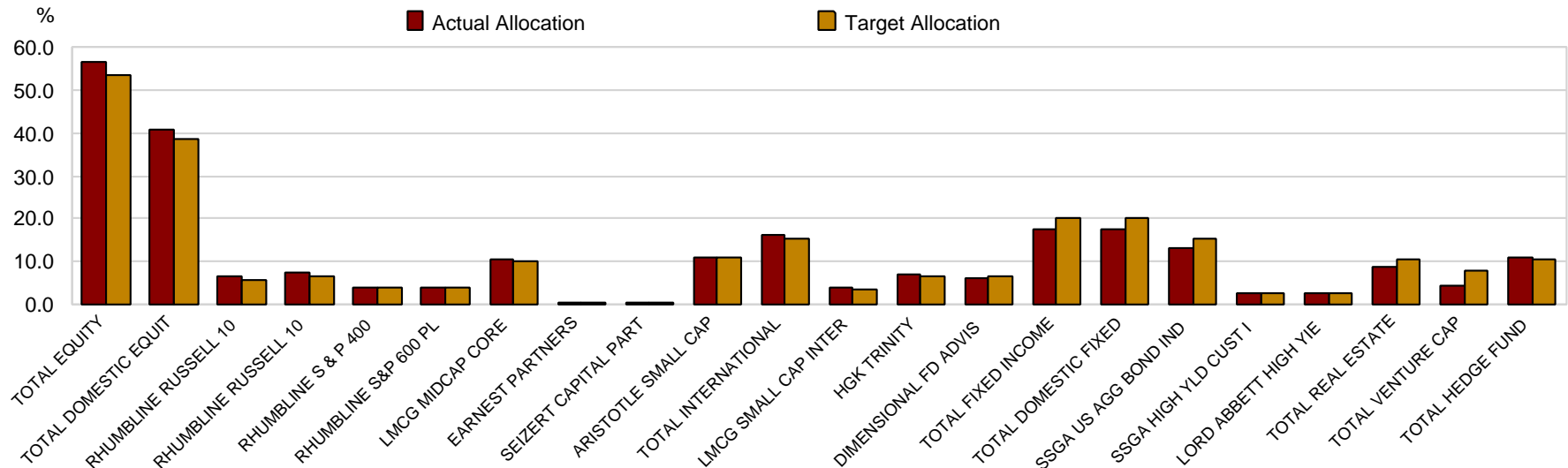
