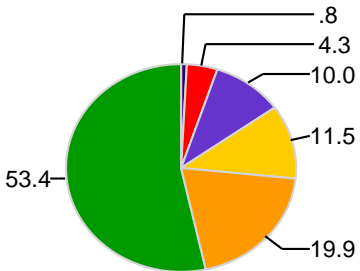

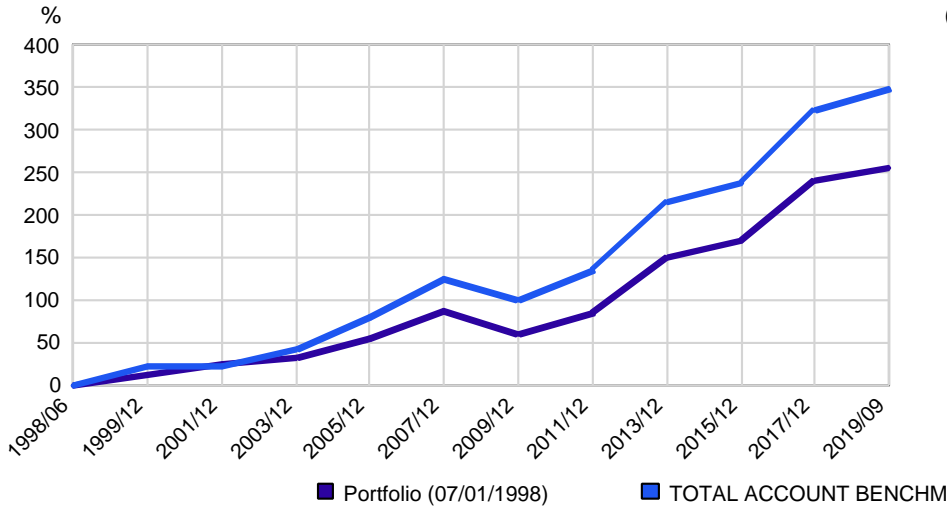

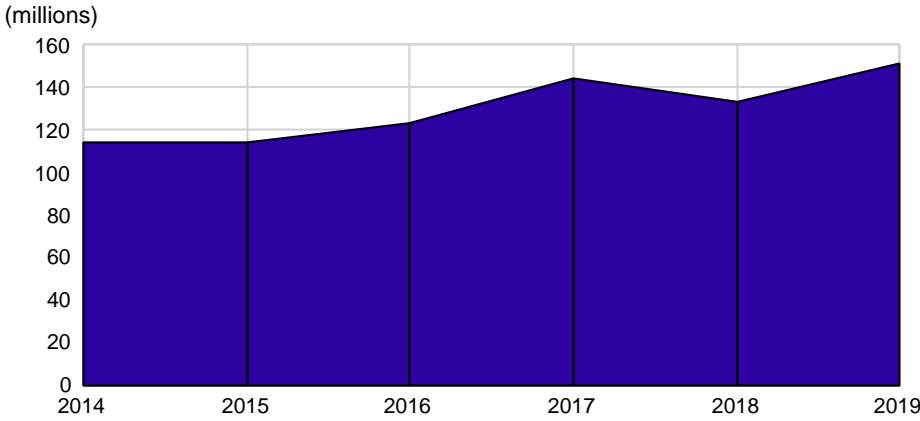

Value Added Over Time

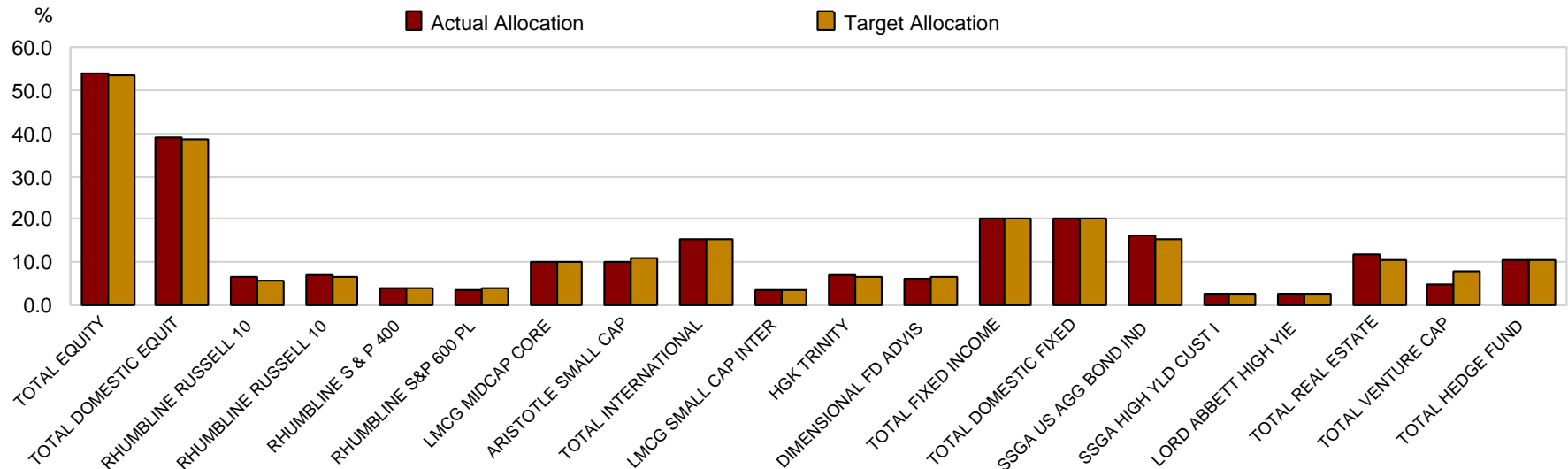
